FURTHER INFORMATION

Right to vote

A member can vote at the Meeting:

- a) in person;
- b) by proxy;
- c) by attorney; or
- d) by corporate representative (if you are a corporate shareholder).

You will be eligible to attend and vote at the Meeting if you are registered as a holder of shares in the Company at 11:00am on Sunday 22 October 2017.

Proxies

A member entitled to attend and cast a vote at the Meeting is entitled to appoint a proxy to attend and vote for the member. The person appointed as proxy may, but does not need to be, a member of the Company. A proxy form accompanies this notice.

If the member is entitled to cast two or more votes, the member may appoint two proxies. If you appoint two proxies, each will require a separate form. If you require a second proxy form please contact the Company Secretary on (02) 6491 7777. If a member appoints two proxies and the appointment does not specify the proportion or number of the member's votes that each proxy may exercise, each proxy may exercise half of the votes.

An instrument of proxy in which the name of the appointee is not filled in is taken to be given in favour of the Chairperson of the meeting to which it relates.

If the member does not instruct its proxy on how to vote, the proxy may, subject to the restrictions to the voting of undirected proxies outlined below, vote as he or she sees fit at the Meeting.

Please refer to the enclosed proxy form for instructions on completion and lodgement. In order for the appointment of a proxy to be valid, the proxy form MUST be received by the Company at least 48 hours before the time for holding the Meeting. Where the proxy form is executed under a power of attorney, the original or an attested copy of the power of attorney or other authority (if any) under which it is signed MUST also be lodged with the Company at least 48 hours before the time for holding the Meeting. Proxy forms received after this time will be invalid.

How the Chairperson will vote undirected proxies

The Chairperson will vote undirected proxies on, and in favour of, all of the proposed resolutions.

Voting Restrictions

Voting by corporate representative

Corporate shareholders who wish to appoint a representative to attend the Meeting on their behalf must provide that person with a properly executed letter or other document confirming that they are authorised to act as the corporate shareholder's representative. The authorisation may be effective either for this Meeting only or for all meetings of the Company.

Lodgement of proxy forms, powers of attorney and authorities

The appointment of a proxy or attorney for the Meeting is not effective unless the instrument appointing the proxy or attorney, and the original or an attested copy of the power of attorney or other authority (if any) under which the instrument is signed, are received by the Company at least 48 hours before the Meeting. Any forms received after that time will not be valid for the scheduled meeting.

Explanatory Notes

1. Annual Financial Report and Directors' and Auditor's Reports

The Financial Report, Directors' Report and Auditor's Report for the Company in relation to the year ended 30 June 2017 will be laid before the Meeting. There is no requirement for shareholders to approve these reports. However, the Chairperson will allow a reasonable opportunity for shareholders to ask questions about, or make comments on, the management of the Company.

Shareholders will be given a reasonable opportunity to ask questions of the Board, management or the auditor about the business and management of the Company, or the conduct of the audit and the content of the Auditor's Report.

2. Adoption of the Remuneration Report

The Remuneration Report explains the Company's remuneration policy for directors, chief executive officer and other key management personnel. The Remuneration Report forms part of the Directors' Report.

The vote on this resolution is advisory only and will not bind the directors or the Company. However, the Board will take the outcome of the vote into consideration when reviewing the remuneration practices and policies of the Company.

Under the Corporations Act, if 25% or more of votes are cast against the adoption of the remuneration report at two consecutive annual general meetings, shareholders will be required to vote at the second of those annual general meetings on a resolution (spill resolution) that another meeting of the Company's shareholders be held within 90 days at which all of the Company's directors (other than the managing director) will cease to hold office immediately before the end of that meeting but may stand for re-election at that meeting.

In accordance with section 250R(4) of the Corporations Act, the Company will disregard any votes cast on this resolution by any member of the key management personnel of the Bega Cheese consolidated group (Bega Cheese Group) whose remuneration details are included in the remuneration report and any closely related party of such member. However, the Company will not disregard a vote if it is cast by such member of the key management personnel or closely related party as proxy on behalf of a person who is entitled to vote, in accordance with the directions on the proxy form. If the proxy is the Chairperson of the Meeting, the Chairperson can also vote undirected proxies on this resolution provided that the proxy appointment expressly authorises the Chairperson to exercise the proxy even though the resolution is connected with the remuneration of a member of the key management personnel. The proxy form prepared by the Company includes this authorisation to enable the Chairperson to vote undirected proxies.

Key management personnel of the Bega Cheese Group are the directors of Bega Cheese and other persons having authority and responsibility for planning, directing and controlling the activities of the Bega Cheese Group, directly or indirectly.

The Board unanimously recommends that shareholders support the adoption of the Remuneration Report.

3. Election of directors

Richard Parbery

Richard Parbery, who retires by rotation in accordance with the Company's Constitution, offers himself for re-election.

Richard Parbery became a Director of The Bega Cheese Co-operative Society Limited in 1988 and has continued to be a member of the Board through the period of the Co Operatives conversion to a company and the successful listing on the ASX.

During this period Richard fulfilled roles such as Deputy Chairman and Chairman of the Finance Committee for both The Bega Co-operative Society and Tatura Milk Industries. Richard is currently a member of the Audit and Risk Committee for Bega Cheese Limited.

In addition, Richard is the Managing Partner of a successful regional Accounting Practice that has been in existence for the last 26 years and specialises in taxation audit and general business advice.

Richard is a fellow of the Australian Society of Certified Practicing Accountants, a Registered Company, Auditor and Registered Tax Agent and is a member of Australian Institute of Company Directors.

Richard also manages a large family dairy farm in Bega NSW.

Richard is pleased to offer himself for re-election.

The directors, other than Mr Parbery, recommend that shareholders vote in favour of the re-election of Mr Parbery.

The Chairperson of the Meeting intends to vote undirected proxies in favour of the reelection of Mr Parbery.

Peter Margin

Peter Margin, who retires by rotation in accordance with the Company's Constitution, offers himself for re-election.

Peter Margin has been an independent director of the Company since 2011 and was last re-elected as a director of the Company on 28 October 2014. He is Chair of the Nomination, Remuneration and Human Resources Committee and member of the Audit and Risk Committee.

Peter has many years of leadership experience in major Australian and international food companies, including Chief Executive of Goodman Fielder Ltd and before that Chief Executive and Chief Operating Officer of National Foods Ltd. Peter has also held senior executive roles in Simplot Australia Pty Ltd, Pacific Brands Ltd, East Asiatic Company and HJ Heinz Company Australia Ltd and is currently Executive Chairman of Asahi Beverages ANZ.

Peter currently serves as a Non-executive director of PACT Group Holdings Ltd, Nufarm Ltd and Bega Cheese Ltd. Peter was previously a Non-executive director of the NSX listed company Ricegrowers Ltd (to August 2015), Chairman and Non-executive director of Huon Aquaculture Ltd (to August 2016), and a Non-executive director of PMP Ltd (to August 2016).

The directors, other than Mr Margin, recommend that shareholders vote in favour of the re-election of Mr Margin.

The Chairperson of the Meeting intends to vote undirected proxies in favour of the reelection of Mr Margin.

Terrence O'Brien

Terrence (Terry) O'Brien was appointed as a Director of the Company by the Board on 18 September 2017 and in accordance with the Constitution, he ceases to hold office at the meeting. Mr O'Brien offers himself for election.

Terry O'Brien was, from 2001 until 2017, the Managing Director of Simplot Australia Pty Limited, the US owned, but Australian-centric, food processor and marketer. Amongst Simplot's stable of brands are John West, Birdseye, Leggo's, Edgell and Lean Cuisine.

Terry retired from Simplot in 2017 and now sits on a number of Australian Company Boards. He is Chairman of the ASX listed Clean Seas Seafood Limited, a Port Lincoln based Aquaculture Company and a Director of Food Innovation Australia Limited, a Government company supporting the food and agribusiness sector. He is also a Director of Bundaberg Brewed Drinks Pty Limited and a Director of Foodbank Australia, a not for profit provider of food aid to Australian families in need.

An accountant by training, Terry has been active in finance and management roles in the textile industry for 10 years and in the food industry for over 30 years, having spent approximately nine years at Cadbury Schweppes and 24 years at Simplot. At Simplot Terry has been responsible for a number of divestments and acquisitions, which alongside organic growth has seen Simplot sales increase nearly threefold during his tenure as Managing Director to become approximately 25% of the global JR Simplot agribusiness company.

The directors, other than Mr O'Brien, recommend that shareholders vote in favour of the election of Mr O'Brien.

The Chairperson of the Meeting intends to vote undirected proxies in favour of the election of Mr O'Brien.
